High School Roofing Repairs

In September we discovered that our high school had received hail damage last year to the roof. We received a check for hail damage in November of \$40,754.60 to repair the roof. We have a \$5,000 deductible with our insurance company. Because the repairs cost over \$25,000 we had to advertise for proposals for the repairs. The proposals were due by December 10, 2003. We received the one following proposal.
