Minutes of School Board Meeting May 19, 2008

1 The Joaquin ISD School Board met tonight in regular session at 7:30 p.m. in the Joaquin Boardroom with the following members present: Mark Stone, Jay Dee Cockrell, Charles Leflett, Ronnie Belrose, Jason Harvey, Josh Cooper, and Jeff Hamilton.

The meeting was called to order at 7:34p.m.

- 2 The invocation was led by Mark Stone, and the Pledge of Allegiance to the United States of America by Jay Dee Cockrell, and the Pledge of Allegiance to the Texas Flag was led by Charles Leflett.

- 4 Agenda Items for discussion, consideration, and possible action:
- 4.1 It was moved by Jason Harvey, and seconded by Ronnie Belrose, to approve the previous meeting minutes. Following discussion, a vote was taken on the motion. It carried unanimously.
- 4.2 The canvassing of the Board election held on May 10, 2008. (Election Code 67.003, 67004(a), Board Policy BBB (Legal))

Mr. Harold Irish, Joaquin ISD Election Judge, was asked to conduct the canvassing of the votes from the May 10th school board election. He gave the following report.

The winner is Jason Harvey. He shall serve one-year term expiring in May of 2009.

Josh Cooper, Jeff Hamilton and Mark Stone were elected for three year terms, in an uncontested race, which shall expire in May of 2011.

Motion by Charles Leflett, and seconded by Jay Dee Cockrell, to accept the report on canvassed votes and declare the results to be official. Following discussion, a vote was taken on the motion. It carried unanimously.

Swearing in of new board members was conducted at this time by Joel McSwain.

- 4.3a Board President

The floor was open for Board President nominations. Mark Stone was nominated. No other nominations were made, nominations were closed.

It was moved by Charles Leflett and seconded by Ronnie Belrose to elect Mark Stone as Board President. The vote was taken. It was unanimous. Mark Stone is the President.

4.3b Board Vice President

The floor was open for Vice President nominations. Jay Dee Cockrell was nominated. No other nominations were made, nominations were closed.

It was moved by Jason Harvey and seconded by Jeff Hamilton to elect Jay Dee Cockrell as Board Vice President. The vote was taken. It was unanimous. Jay Dee Cockrell is the Vice President.

4.3c Board Secretary

The floor was open for Secretary nominations. Ronnie Belrose was nominated. No other nominations were made, nominations were closed.

It was moved by Jay Dee Cockrell and seconded by Charles Leflett to elect Ronnie Belrose as Board Secretary. The vote was taken. It was unanimous. Ronnie Belrose is the Secretary.
