 - 5.2 It was moved by Frank Cooper, and seconded by Jeff Hamilton, to approve the Investment Broker's List (attached) and local policy CDC Other Revenue Investments. Following discussion, a vote was taken on the motion. The vote was 5 for with 1 abstention (Josh Cooper). Motion carried.
