Minutes of Special School Board Meeting

May 15, 2012

The Joaquin ISD School Board met in special session at noon in the Joaquin Boardroom with the following members present: Jay Dee Cockrell and Josh Cooper Member absent: Jeff Hamilton, Charlie Baker, Charles Leflett, Frank Cooper and Ronnie Belrose

- 2 Jay Dee Cockrell, President, called for the canvassing of the Board election held on May 12, 2012. (Election Code 67.003, 67004(a), Board Policy BBB (Legal))

Mr. Harold Irish, Joaquin ISD Election Judge, was asked to conduct the canvassing of the votes from the May 12th school board election. He gave the following report and the results calculated by the Election System Model 100 voting machine. (Report Attached)
